# **Position Summary**

This position is responsible and accountable for the functions to implement a highly visible and proactive division of evaluation, assessment, accountability, research, school improvement, data services, system accreditation, and special projects. This position will be responsible for providing sound theoretical information that is relevant and useful for evaluation and management of school improvement data. The departments in this division include Assessment; Accountability; Research; School Improvement; Data Services; and System Accreditation. This position oversees the creation of consistent reporting business rules, including finding efficient solutions to data collection requirements and reports. The person selected for this position is directly responsible to the Chief Academic Officer, Academic Unit.

# **Essential Duties and Responsibilities**

The list of Essential Duties and Responsibilities is not exhaustive and may be supplemented.

- 1. Provides support in collecting, analyzing, and reporting data for Clark County School District (CCSD) monitoring reports, accountability reports, and federal grants, as applicable.
- 2. Oversees the development, administration, and reporting of large-scale summative as well as formative assessment programs.
- 3. Provides support and training regarding data analysis to administrators districtwide to increase organizational knowledge and the ability for school and CCSD leaders to interpret and utilize data in decision-making.
- 4. Assists principals with the implementation, monitoring, and evaluation of School Improvement Plans (SIPs) and formative assessments.
- Designs and oversees the districtwide implementation, training, and support for an online assessment program, standards-based report card, Nevada school performance framework, growth model reports, and achievement data warehouse.
- 6. Maintains data and records to provide reports to meet federal, state, and CCSD accountability requirements.
- 7. Supervises CCSD's participation in the Trial Urban District Assessment (TUDA) as part of the National Assessment of Educational Progress (NAEP) testing program.
- 8. Supervises state-mandated accountability, dropout, graduation, data collection, verification, and reporting.
- 9. Serves as liaison to Nevada Department of Education (NDE) regarding accountability reporting, testing, School Performance Framework (SPF) designations, and applicable federal requirements.
- 10. Ensures compliance with state mandates regarding test security, accountability reporting, and Nevada Revised Statutes (NRS) 385 requirements.
- 11. Oversees the Title I 1003(a) grant, and other applicable audits.
- 12. Assists and provides instructional leadership to principals and other school administrators in raising student achievement and reducing the achievement gap.
- 13. Supports mechanisms to provide accurate data in order to guide data-driven decision-making at the CCSD and school level.
- 14. Assists the community, higher education, research partners, and other community partners with data requests in an accurate and timely manner.
- 15. Oversees and screens all research and Memorandum of Agreement (MOA) student data requests to CCSD.
- 16. Oversees the districtwide survey and surveys for standard student attire.

- 17. Serves as the Executive Leadership Team sponsor of the system accreditation cycle, overseeing the related processes.
- 18. Plans, organizes, directs, and participates in the development and implementation of districtwide professional learning and technical assistance for test administration and security, data analysis, and the continuous improvement process.
- 19. Plans, organizes, directs, and participates in the development and implementation of multiple district-wide, enterprise-level web-based applications that support data collection and processes within the Teaching and Learning Unit.
- 20. Collaborates with the Human Resources Unit (HRU) to provide accurate achievement data for teacher and principal evaluations.
- 21. Plans, organizes, controls, and directs the functions of the unit, including evaluation of programs, accountability, and test data analysis.
- 22. Develops and provides user-friendly data to school sites and CCSD staff that will ensure effective districtwide implementation of CCSD's strategic plan.
- 23. Oversees the development of public dashboards and reporting within the data scope of the division, providing user-friendly data to increase transparency with educators, parents/guardians, the community, policy makers, and the Nevada legislature, with quick access to timely and comprehensive data about the state of education in CCSD.
- 24. Assists with the development, monitoring, and reporting of the district's strategic plan, including multiple annual presentations to the Clark County School District Board of School Trustees and data included in quarterly municipality reports.
- 25. Organizes, coordinates, and streamlines data collection between units, departments, and divisions.
- 26. Consults with and advises CCSD personnel and others on the most effective means of collecting and utilizing data to increase student achievement.
- 27. Monitors assigned budgets.
- 28. Keeps abreast of technical, legislative, and learning issues affecting the work of the division.
- 29. Serves as a liaison with other departments/divisions/units and communicates regularly to ensure maximum efficiency in the delivery of services to schools.
- 30. Promotes parent/guardian participation and provides responses to address parent/guardian/community issues/concerns.
- 31. Attends Board of Trustees' and other meetings, as required.
- 32. Provides relevant data, analysis, and advice applicable to CCSD's legislative agenda.
- 33. Performs other duties related to the position, as assigned.

# **Position Expectations**

- 1. Possess knowledge of laws, rules, regulations, and policies governing largescale assessment and evaluation in a public entity setting.
- 2. Work collaboratively and positively with a variety of staff and administrators while assisting them to use data to improve student learning.
- 3. Demonstrate respect for student and staff populations; respond to others utilizing responsive strategies.
- 4. Present assessment results to various audiences using clear and effective communication tools to ensure understanding; can explain technical information in layman's terms.
- 5. Exhibit high personal motivation, energy, and enthusiasm; set high performance standards of self and others.
- 6. Motivate others and design activities to assist others in meeting organizational goals, and demonstrates skills in facilitation of groups to accomplish tasks and to make decisions.
- 7. Be receptive to new ideas and change, and commit to personal and professional learning.
- 8. Establish positive relationships with an active commitment to all students and staff.
- Foster an environment that focuses on quality results while motivating, developing, and supporting staff, encouraging continuous improvement, and working effectively as a member of a team.
- 10. Possess a sense of vision and project that sense, involving others in accomplishing goals and solving problems, and interacting with groups successfully.
- 11. Exercise good judgment, insight, self-awareness, integrity, and responsiveness when interacting with diverse employees, students, and patrons.
- 12. Continue one's own lifelong learning, develop talent and leadership skills in others, provide critical feedback, and receive critical feedback in order to maintain high standards for oneself and the organization.
- 13. Communicate effectively both written and verbally to make clear as well as persuasive presentations to groups.
- 14. Incorporate competent strategies and utilize responsive communication and engagement strategies with all members of the school community.
- 15. Ability to recognize and report hazards and to apply safe work methods.

# **Position Requirements**

## **Education and Training**

An earned master's degree from an accredited college or university in the area of educational leadership, statistics, assessment, program evaluation, or other area applicable to the position responsibilities.

### **Licenses and Certifications**

Hold or be able to acquire, by time of appointment to the position, appropriate Nevada administrative license, as appropriate.

## **Experience**

- Have previously demonstrated five (5) years of successful licensed teaching experience in an accredited K-12 public or private school; and, be able to acquire, by time of appointment, appropriate Nevada school administrative endorsement; or,
  - Have previously demonstrated at least three (3) years of successful licensed teaching in an accredited K–12 public or private school; and, currently hold a valid Nevada school administrative endorsement.
- 2. Have previously demonstrated at least two (2) years of experience as a contracted school principal in an accredited K–12 public or private school; or; Have at least five (5) years recent successful district-level leadership experience\* as a contracted administrator in a large (minimum of 30,000 students) urban public school district.
  - \*Leadership experience may include, but is not limited to: school administration, curriculum development, professional development, program evaluation and improvement, instructional assessment and accountability, and educational technology.
- 3. Experience supervising and monitoring the collection, verification, and reporting of assessment and accountability data.
- Experience in developing and leading staff development, data-driven decisionmaking, program and school evaluation, accountability systems, school improvement, and curriculum review.
- 5. Experience working in, or working with, a large, urban, educational system comprised of diverse constituents.
- 6. Present or previous experience with strategies or research targeting student achievement in diverse educational settings.
- 7. Successful performance in the position held at the time of application.

#### **Preferred Qualifications**

- 1. Oversight of a large-scale summative and formative assessment program.
- 2. Recent experience with school accountability measures and data analysis, leading to systemic school improvement planning.
- Proficiency with regard to the purposes of different quantitative analyses, including multiple regression and factor analysis; preference will be given to candidates who demonstrate a sophisticated knowledge and ability to utilize advanced statistical analysis methods and software.
- 4. Ability to make effective use of relevant technology, including that used for scanning and scoring tests and surveys, sophisticated graphing and presentation software, database programs, statistical packages and districtwide information management systems.
- 5. Successful oversight of an online data warehouse for accountability and assessment data.
